62. Narrative of Supplemental Report On 06/11/13, at 2311 hours, Officer S. Lopez and I responded to an OIS at 3476 Van Buren Blvd. (Chevron). We arrived on scene and I noticed that a male subject later identified as W1/Lambe was sitting on the east curb line of Van Buren Blvd. I contacted W1/Lambe and he gave me the following recorded statement in summary: W1/Lambe said he was at the USA gasoline station on Van Buren Blvd. just south of 91 freeway, when he saw a police helicopter in the air above the Chevron just north of the 91 freeway on Van Buren Blvd. W1/Lambe said he walked north bound on the east curb line of Van Buren Blvd. to see what was going on. W1/Lambe said he noticed a vehicle had crashed into the median on Van Buren Blvd. just east of the Chevron. W1/Lambe said he also noticed that an unknown black male was lying on the ground next to the vehicle. W1/Lambe said he did not see anything else and only heard "pop, pop". W1/Lambe said he hear 4-5 gun shoots. W1/Lambe hangs out behind the Albertson at 2975 Van Buren Blvd. W1/Lambe has two clown tattoos on each shoulder blade.
