CITY PLANNING COMMISSION TENTATIVE 2013 SCHEDULE

Upon submittal the application will be reviewed for completeness and adequacy of the materials within 30-days, pursuant to Title 19 – Section 19.660.050 and Gov. Code Section 65943. Once the application is deemed complete by the case planner it will be scheduled for hearing in accordance with Table 2 below. Public hearings are held the first and third Thursday after the first Tuesday of each month at 9:00 a.m. in the Art Pick City Council Chambers. Applicants should attend the meeting. Copies of the staff report and agenda are mailed to the applicant on the Friday preceding the meeting. The Subdivision Committee meeting applies to Tract Maps, Parcel Maps and Waivers of Parcel Map. Subdivision Committee meetings are held in the Third Floor Large Conference Room unless otherwise specified. All cases subject to the California Environmental Quality Act (CEQA) will have an Environmental Initial Study ready for review on the *Publication of Notice* date.
