program guidelines:

- This program is available to Riverside Public Utilities' (RPU) residential electric customers.
- Application must be submitted within ninety (90) days of receipt purchase date.
- A copy of the dated sales receipt must be provided and is subject to verification.
- Rebates will be paid to the Riverside Public Utilities' electric customer of record.
- Rebates will be issued for retrofit projects only. New construction does not qualify.
- Products installed are subject to inspection for program compliance. Failure to comply may forfeit rebate.
- Rebate amount will not exceed amount of purchase of weatherization measures.
- Rebates are given on a first-come, first-served basis subject to fund availability and change without notice.
