BUILDING PERMIT AND PLAN CHECK FEES

This document will assist you in calculating an estimate of building permit and plan check fees for your proposed construction project. Please keep in mind that this is an estimate of **Building & Safety Division fees only** and that there may be additional development fees from other City Departments including Planning, Public Works, Fire, and others. Furthermore, there may be additional development fees from outside agencies, such as the County Health Department, your local School District, or other federal, state, or local agencies.

BUILDING DATA:

The following values have been adopted by the City of Riverside as representative of the typical cost of construction for the purpose of calculating Building Permit and Plan Check fees. The values are not intended to represent the actual cost of constructing a given project. Multiply the total square footage of the building by the "Per Square Foot Value" shown below. This value will represent the total cost of construction for the purpose of calculating Plan Check and Building Permit Fees.
