NARRATIVE: On 10-31-17, I was working as a uniform Police Officer with the Riverside Police Department in the City of Riverside. I heard a radio call of a male subject assaulting staff members at "Castle View Elementary School" located at 6201 Shaker Dr. I responded to the location to assist.

Upon arrival, Dispatch advised the suspect was in building "A", classroom "A1" and was barricading himself inside. I self deployed as a sniper and took a position on top of the "B" building roof which was located about Met.

Hours later, after the Metro Officers finally made entry into classroom "A1," I saw an elderly White female victim being escorted out of the classroom by Officers. After the scene was rendered safe, I remained at the school and guarded the armored vehicle as directed by Sgt. Goodson.
