On 11/6/17, I was contacted by O/Rivera from Stater Brother's. O/Rivera is the Supervisor of Investigations/Corporate Security for Stater Brother's Stores. O/Aaron notified O/Rivera that S/Kennon was possibly in Stater Brother's store #201 on the morning of 10/31/17 at approximately 0730 hours.

Two employees mentioned to the store manager that the subject they saw pictured on social media, that was associated with the Castleview Elementary School lockdown, looked like S/Kennon and had been in the store showing aggression to another customer earlier that same morning.

O/Rivera provided a travel drive and a DVD with video surveillance footage of S/Kennon at the store. The DVD and travel drive provided were booked into evidence. The cashiers wrote statements regarding the behavior of S/Kennon that morning. See attached statements. The Stater Brother's employees were Irene O'Keefe, ID# 102853 and Xochilt Lacy ID#124697.

S/Kennon was seen carrying a small female child (*possibly his daughter*) and appeared to be at the store with a woman (*possibly his mother*.) He walked through the line waiting at a cash register to checkout, going the opposite direction of the line, to enter the store. It appeared as if he exchanged words with a customer in that line. (*There is no audio on the video*.) He walked back toward the customer a few times but there was no physical fight between them. While standing in line, the child he carried leaned toward the woman he is with as if she wanted to be held by the woman. S/Kennon leaned and back and turned away. The child remained in his arms. S/Kennon was also seen walking in front of a moving vehicle in the parking lot as he left. S/Kennon made a hand gesture to the driver. The woman with him did not walk to the front of the vehicle.

The statements, DVD and travel drive were booked into evidence at Magnolia Station.


