1 **Evidence:**

2 Audio recorded statement obtained from my Department issued PUMA recorder that was downloaded
3 at the Lincoln station.

5 **Narrative:**

6 On 02-20-17, at about 2253 Hours, Officer Miller and I responded to a "Shots fired" call in the area of
7 MacArthur and California. We assumed a perimeter position on California west of Jackson until we were
8 reassigned to the area of MacArthur and Sage. Upon arrival, I interviewed O-Antonio Escobar who
9 provided the following summarized statement.

11 O- statement:

12 O- said he was sanding some furniture on the side of his house when he heard a series of about
13 18-24 gunshots. About seven to eight minutes later he saw a Hispanic Male adult (S-1) limping up the
14 street. S-1 "took notice" to O- and said he needed help. O- said he knew S-1 because he
15 bought an amplifier from him about 15-20 years ago. He also said he saw S-1 a few ago on Sage in a car
16 with a female. I asked O- what S-1's name was and he said he didn't know his name and he also
17 said he really didn't know him, but he said he believed his name was "Danger" or "Stranger" and said he
18 was a Southside Riva gang member. O- said S-1 was armed with a gun and S-1 walked into the
19 house and he would not let O- leave his sight. O- said S-1 was shot in the leg or foot and
20 was bleeding all over O- house. O- did not provide any other information.

22 Officer Miller and I transported O- and O- to the Magnolia station where they were
23 interviewed by RPD detectives. Officer Miller and I transported O- and O- to the area of La
24 Sierra and Cypress and dropped them off at the corner. O- said they had a friend who lived in the
25 area.
