On Tuesday, February 21, 2017, at approximately 4:00 a.m., I received a call from Detective P. Fernandez. Detective Fernandez requested that I respond to [REDACTED] and assist on a SWAT/ENT call-out. Responding from my residence I arrived on scene at approximately 5:00 a.m. On arrival I was tasked with assisting Officer R. Quillen with gathering information on the suspect, Marcelino Arthur Garcia. Using the Riverside Police Department's records database I found that S/Garcia had listed [REDACTED] as his wife. Her phone number is [REDACTED]. I called [REDACTED] via phone and obtained a brief synopsis of her relationship with S/Garcia. The following is a summary of our conversation. [REDACTED] characterized her relationship with S/Garcia as "messed-up". She was in the process of finalizing her marriage with S/Garcia and was allowing S/Garcia to have supervised visitation with their three children - visitation was not court mandated. [REDACTED] said she and S/Garcia have been divorced since 2014 but kept in touch because of the children. The last time S/Garcia saw the kids was three weeks ago. (Continued on page 2).

6 at [REDACTED] [REDACTED] phone number is [REDACTED]

8 During my conversation with [REDACTED] she inquired about the status of the investigation and was receiving
9 information that only a person present at the scene would have known. I asked [REDACTED] how she came upon
10 the contemporaneous information. [REDACTED] said she was receiving updates from “people in the area” but
11 refused to provide any further information.
