| 62. Narrative of Supplemental Report On 2/20/2017 I was working as a uniformed Patrol Supervisor for the Riverside Police Department. At approximately 2253 hours, I heard the Officers identified as 3R40 broadcast "Shots fired." Additional radio traffic gave their location and outlined their current situation. A subject had shot at them and fled the scene. A vehicle still had two occupants and a female was in a prone position in the street. I responded to the scene. Officer Hammer and I called the female from the prone position back to us and we took her into custody. I checked on Officer Espinoza and Officer Carmona and they were fine. Sergeant Goodson and I coordinated a felony stop on the occupants inside the vehicle. Sergeant McCoy and I coordinated a search of yard where the suspect was last seen running to make the area safe for officers and responding investigators. I took a public safety statement from Officer Espinoza. He told me he shot between 10-15 rounds in an e n and northeastern direction and there was still one suspect outstanding. After the initial contact and before we left the scene, Officer Carmona had retrieved his rifle and a plate carrier. I told him to secure those back inside his police unit. Both officers asked if they could retrieve their cell phones, keys and personal effects from the unit. I told them they could and walked up to the unit with them. Officer Carmona took his cell phone. Officer Espinoza took a small bag he carries to work that holds his phone, wallet and keys.

I drove Officers Espinoza and Carmona to the Magnolia station. I ordered them not to discuss the incident with each other. We sat in the conference room and were eventually joined by Sergeant Lindgren for peer support, Detective Melendrez, who was there representing the RPOA, and the officer's lawyer. I was relieved by Central Investigations at approximately 0500 hours.
