1 NARRATIVE:

2
3 On 02-20-17, at approximately 2350 hours, I was notified by RPD Dispatch of a full METRO call out,
4 reference an Officer Involved Shooting and an outstanding suspect. I responded to the area of
5 Garfield/Van Buren where I was briefed with METRO personnel and advised the wanted suspect was
6 possibly located in the area of the 9300 block of Sage.

7
8 I was assigned to be the driver of the Armored Rescue Vehicle (ARV) and drove the ARV to the area of
9 [REDACTED] where patrol personnel were holding containment. During the course of the investigation, it
10 was learned that S/Garcia was armed and barricaded within the residence located at [REDACTED]. I
11 positioned the ARV to the front of the location where I would later provide announcements, ordering
12 S/Garcia to exit the residence. I assisted in providing announcements for approximately 30 minutes;
13 however S/Garcia did not exit the residence.

15 During the course of the METRO operation, the residence at [REDACTED] caught fire. I assisted METRO
16 personnel in utilizing Riverside Fire Department equipment and attempted to put out the fire with other
17 METRO officers. Eventually, Riverside Fire Department personnel took over the structure fire and I
18 assisted in providing cover for them.

20 Once the fire had subsided, I was debriefed with the rest of METRO personnel and subsequently cleared
21 the scene.
