<p>As a member of the Riverside Police Dept. Emergency Negotiation Team (ENT) I responded to the intersection of Macarthur Rd. and Sage Ave. on 2-21-17, at approximately 0245 hours, regarding a full SWAT callout. I received initial information there was a barricaded subject at [REDACTED] as a result of an officer involved shooting (OIS). At that time I had responded to the above intersection in an RPD equipped motorhome, prepared the equipment for deployment and was assigned as the "primary negotiator." At about 0549 hours members of the RPD METRO Team deployed a "throw phone" into the interior of [REDACTED] in attempt to make contact with the subject who had refused to exit the residence. Several attempts were made to contact the subject via the equipment "throw phone" till about 0645 hours. During the deployment of the above equipment there was video, audio and computer data recorded and downloaded onto three separate discs (evidence item #PEF001). I booked evidence item # 001 into RPD Property, see attached Property Report for details.</p>
