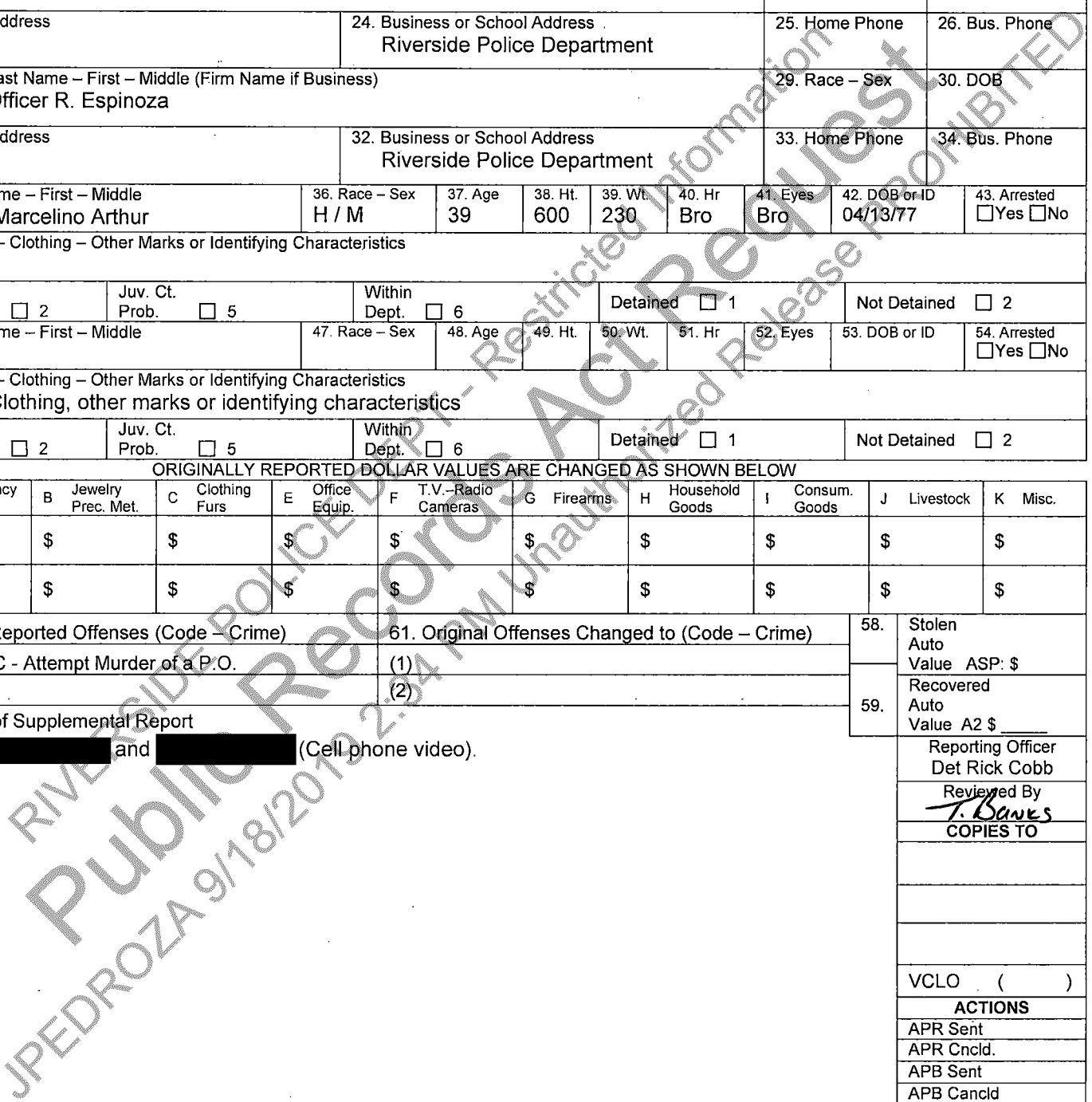

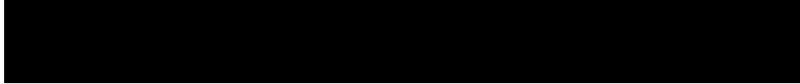

Details

While conducting this investigation, I learned that two women witnessed a portion of the shooting and took a video of the incident using a cell phone. I contacted W-1 [REDACTED] and W-2 [REDACTED] at California Avenue and Van Buren Boulevard.

Both said they were in their car down the street from where the shooting occurred. They said they saw police arrive, but did not pay attention. They then heard gunshots. W-1 [REDACTED] began video-taping the incident with her cell phone. They then heard another round of gunshots. They were frightened and ducked down in their car. They could not see what was happening.

W-1 [REDACTED] sent me the video from her cell phone. The video does not show anyone due to the darkness. Gunshots are heard on the video, with W-1 [REDACTED] and W-2 [REDACTED] talking in the background.

A copy of the video was booked as evidence.
