I responded to the termination of the pursuit near the intersection of Arlington Ave. and Street Ave., I saw there were numerous officers from the Riverside Police Department and Hemet Police Department on scene. Due to vehicles stopped in the eastbound lane on Arlington Ave. in the crime scene, I assisted officers in diverting the vehicle westbound Arlington Ave. out of harms way.

Since vehicle continued to travel eastbound Arlington Ave., I used my police vehicle to block the eastbound lane at Madison and Arlington Ave. until streets arrived at about 2220 hours to place barricades to block off the eastbound lane and the right hand turning lane on Madison Ave.
