Narrative of Supplemental Report On Friday, 07/20/18, at approximately 1946 hours, I was assigned to uniform patrol in the City and County of Riverside when I responded to assist the Hemet Police Department reference a pursuit in which the suspect vehicle was shooting at officers. I trailed behind the pursuit until the suspect vehicle reportedly stopped on westbound Arlington Avenue, east of Streeter Avenue. I arrived on scene and assisted officers in surrounding the suspect vehicle. I looked westbound and observed heavy traffic flow through the intersection of Arlington Avenue and California/Streeter Avenue, located in the potential line of fire from officers on scene. With sufficient units on scene, I went to the intersection and stopped northbound traffic from south of Arlington Avenue. I continued to conduct traffic control operations at that location until Sergeant Munoz relieved me from that assignment at 2200 hours.
