1 **Narrative:**

2 On 07/20/18, partner Officer Espinosa and I were working patrol in the City and County of Riverside,
3 California. We were in police uniform and in a marked police vehicle. At approximately 1950 hours, we
4 responded to assist with an in progress vehicle pursuit.

6 The vehicle was on Arlington Ave. just east of Streeter Ave. when we arrived on scene. We observed
7 assisting officer conducting a high risk felony stop on the vehicle. We conducted traffic control at the
8 intersection of Arlington Ave. and Street Ave. to divert traffic away from the area. We remained on traffic
9 control until we were asked to set up a perimeter around the incident with crime scene tape. After we
10 established the perimeter, we canvassed the area just south of Bank of America for shell casings and
11 evidence. We were unable to locate any evidence. We remained on scene until we were relieved of our
12 duties at approximately 0810 hours on Saturday.
