**Details:**

On Friday, July 20, 2018, at approximately 1946 hours, I responded to the area of Arlington Ave. and Streeter Ave. in the City of Riverside, regarding a vehicle pursuit. While driving to the area of the pursuit, on-scene officers advised shots were fired over the radio. I responded to the scene shortly after the announcement and positioned my vehicle at the corner of California Ave. and Melrose St. Upon arrival, I noticed several vehicles stopped in the middle of Arlington Ave. just east of Streeter Ave. I observed bystanders hiding on the ground by their vehicles. Once it was safe to do so, I escorted the occupants of the vehicle to cover at the south east corner of Melrose St. and California Ave. I stayed at the location as a perimeter role and assisting in guiding pedestrians and traffic away from the scene. I did not enter the crime scene and was not involved in the vehicle pursuit. On Saturday, July 21, 2018, at approximately 0315 hours, I was relieved from my perimeter position. This concluded my involvement in this case.
