62. Narrative of Supplemental Report On 07/20/18, at approximately 1951 hours, I was working traffic on my marked Police uniform while in full police uniform. I had worked day shift (0600-1600 hours) that day and was still at Lincoln Station working on reports and other paperwork. I heard a pursuit go out on channel one in which Officers were getting shot at by someone from inside the suspect vehicle. I got on my marked Police motorcycle and left Lincoln Station and headed out towards the pursuit. I had dispatch log me back on and put me out on the channel one traffic. I heard that the suspect vehicle was stopped on Arlington near Streeter. As I was headed that way I heard a Sgt. request that traffic on Arlington be shut down. I assisted the Officers with shutting down East and traffic on Arlington just West of Streeter. I helped clear out the bystanders from that area also. I then assisted Officers shut down Melrose, just South of California. Once the suspect was pronounced deceased, Sgt.
