Incident Number: On the listed date and time, in the city and county of Riverside, I was assigned to work uniformed patrol in a marked city of Riverside Police car. At this time I heard RPD Dispatch advise RSO and Hemet PD were in pursuit of a vehicle that was shooting at them on the north bound 215 FWY. I then heard the pursuit enter the city of Riverside via Van Buren Blvd. and that S1 continued to shoot at RPD Officers in the pursuit. I paralleled the pursuit till it came to the termination point at the listed location after an Officer Involved Shooting occurred. At this time Officer's Watkins, Hoyos and I held lethal cover on the suspect and suspect vehicle until RPD Metro officers relieved us, and confirmation of S1 being deceased.
