- 2 On 7-20-2018, at approximately 1934 hours, I was on routine patrol in the City of Hemet, when Crime
- 3 Suppression Unit Officers began to pursue a vehicle. I responded Code 3 to their location as the
- 4 pursuit continued to travel westbound through the city.

- 6 During the pursuit, CSU Officers broadcasted, "Shots Fired" in the area of California Avenue and
- 7 Florida Avenue and that the suspect was observed tossing items out of the window. As I got near the
- 8 western edge of the city, the pursuit had already left the city. In order to locate the items that the
- 9 suspect threw from the vehicle, I stopped westbound traffic at the intersection of California Avenue
- 10 and Florida Avenue and began to search the area for any evidence. I did not locate any evidence or
- 11 items thrown from the vehicle. After the search on Florida Avenue, I then went to the intersection of
- 12 Tamarindo Street and California Avenue and stopped all traffic traveling northbound and southbound
- on California Avenue to preserve the crime scene where CSU Units broadcasted, "Shots Fired". I
- 14 maintained the position until the investigation was completed.
