# HEMET POLICE DEPARTMENT

## ASSIGNMENT:

On 07/20/18, at approximately 1934 hours, I was on patrol in the area of 100 North Columbia Street, in the City of Hemet/ County of Riverside, when I heard Sergeant Mouat advise he was in vehicle pursuit in the area of Devonshire Avenue and Kirby Street. Sergeant Mouat advised he was pursuing a white Chrysler convertible (CA#7JPW282) and he was the only unit pursuing. I heard Sergeant Mouat advise the vehicle was being driven by a 246 P.C. suspect who was possibly armed with a firearm. I was driving a marked Hemet Police Vehicle (Unit# 3078) equipped with emergency lights (red forward facing) and sirens. I was wearing a Hemet Police Department Class B uniform.

## NARRATIVE:

I began responding "Code-3" to Sergeant Mouat's location to assist. While responding, Sergeant Mouat advised, "Shots fired" over the police radio and said the subject was shooting back at him. As the pursuit continued westbound on Florida Avenue at a high rate of speed and out of the city limits, I continued to follow its path as I attempted to catch up to Sergeant Mouat.

I stayed behind the pursuit until Riverside PD took it over, in the City of Riverside. Once RPD took control of the pursuit, I trailed them to the pursuit termination point. After arriving at the termination point, a RPD Lieutenant (unknown) advised me RPD had the scene under control and did any outside agency assistance. I cleared from the scene and returned back to the City of Hemet. This concludes my involvement in this incident.
