DETAILS

3 On Friday, July 20th, 2018, I was working patrol operations in unincorporated county area of Perris,
4 County of Riverside. About 1935 hours, dispatch advised Hemet Police officers were in a vehicle pursuit near
5 the intersection of California Rd and St Hwy 74 and the driver of the vehicle was shooting at the pursuing
6 officers. I responded from the area of Scott Rd and El Centro Ln to assist Hemet Police officers. Hemet officers
7 pursued the vehicle west on St Hwy 74 where it entered the 215 Freeway. Riverside Sheriff Deputies in the
8 area joined the pursuit and advised the suspect again fired on pursuing officers near St Hwy 74 and Trumble
9 Rd. The suspect vehicle then traveled north on the 215 Freeway to the Van Buren Blvd exit. The vehicle exited
10 Van Buren Blvd where a Riverside County Sheriff's deputy was waiting. As the suspect vehicle exited the
11 freeway, the deputy advised the driver shot at him several times. The suspect vehicle and pursuing units
12 continued west into the Riverside City limits where the pursuit was taken over by Riverside Police Officers.

14 I arrived at the northbound 215 Freeway offramp to Van Buren Blvd where I was met by Deputy
15 Thomas and Deputy Sivilay. Together we secured the intersection and stopped all traffic flow through the area.
16 We conducted a search of the area where the suspect shot at deputies and located a single spent .40 caliber
17 casing in the center westbound lane of Van Buren Blvd, just prior to the freeway overpass. Additionally, we
18 located three partial projectile jackets near the bottom on the off ramp. A Riverside Sheriff Forensic
19 Technician arrived at our location about 2247 hours and processed the scene. About 2300 hours, investigators
20 from the Perris Station arrived at the location and took control of the scene. I had no further involvement on
21 this incident and I was not involved in the pursuit. See the initial report for further information.
