**DETAILS:**

1  
2  
3 On Friday, July 20, 2018, about 1945 hours, I was in a marked black/white patrol unit, patrolling the  
4 area of Alexander Street X Gaston Road, in Riverside County, known as the unincorporated  
5 community of Mead Valley. Deputy Ray (5SEK9) advised he was assisting Hemet Police  
6 Department reference they were in pursuit of 246 P.C. (Shooting) suspect in an unknown year silver  
7 and black Chrysler Convertible (unknown license number).

8  
9 Deputy Ray advised the pursuit was heading towards the City of Perris and the speeds were  
10 approximately 100 mph. He said the pursuit was traveling westbound on Highway 74 crossing  
11 Trumble. He advised the suspect was shooting at deputies and they were entering the northbound I-  
12 215 freeway and speed still at 100 mph. He advised to have Perris units to code Alex (on the off and  
13 on ramps of the freeway).

14  
15 I advised dispatch I would code Alex at Van Buren X I-215 freeway. I position my marked black and  
16 white patrol unit number 15-019, in southeast position where I could monitor the pursuit. The pursuit  
17 continued northbound on the I-215 freeway until the suspect exited the off-ramp to Van Buren  
18 Boulevard.

19  
20 As the suspect exited the freeway, and at the top of the off-ramp, the suspect started shooting  
21 toward my marked black and white patrol unit. The suspect shoot approximately 5 to 6 shots at my  
22 unit as he started traveled westbound on Van Buren Boulevard. Sgt. Morovich (SE115) authorized  
23 me to join in the pursuit. I was the fifth (5) unit in the pursuit behind Sgt. Morovich and started a  
24 roadblock for the concern and safety of the public.

25  
26 As the pursuit continued westbound Van Buren Blvd at speeds of 90 mph, the suspect lost control of  
27 vehicle at Van Buren Blvd X Plummer Road. The suspect overcorrected and gained control of his  
28 vehicle and continued traveling westbound on Van Buren Boulevard. As the pursuit continued on  
29 Van Buren Blvd towards Orange Terrance, Sgt. Morovich waved me to take over the fourth (4)  
30 position in the pursuit.

31  
32 The pursuit continued westbound on Van Buren Blvd at speeds at 90 mph. Sgt. Morovich requested  
33 Riverside Police Department takeover of the pursuit. I disconnected the from pursuit at Van Buren  
34 Blvd X Ranch Road, Woodcrest. I drove back to the 1-215 freeway and Van Buren Blvd and blocked  
35 the freeway to look for spent casings. Evidence was discovered at the scene and I was relieved from  
36 my location at about 2345 hours by Perris Station Detectives. (See Deputy Ray initial report on the
