On 07-23-18, I spoke to V-Garcia by phone regarding this incident. Officer Gutierrez originally interviewed [REDACTED] at the time of the incident. She prepared a very detailed report of the interview. I decided to go over Officer Gutierrez's report with [REDACTED] to make sure the accounts of the incident were correct, rather than conduct another full interview.

I read the report to Garcia. He said the report was accurate, with the exception of two things. He said S-Russell never went completely "out" when he applied the Carotid restraint. He said Russell stopped struggling, but did not go "out". He also said that while he was restraining Russell, Russell kept struggling and saying "Fuck you" numerous times.

[REDACTED] agreed with the remainder of the report.
