I received a thumb drive with video surveillance taken from McDonalds at the time of this incident. Management at McDonalds gave me the video.

The video surveillance contained five cameras from inside McDonalds. Different cameras captured S-Russell entering the business and assaulting V- as well as S-Russell going behind the counter and attempting to assault employees. The cameras capture V- subduing S-Russell and detaining him until police arrive. The cameras capture Officer Cuevas handcuffing S-Russell and waiting for assisting officers arrive. The cameras then capture Officer Cuevas and Sergeant Medici carrying S-Russell outside to be treated by paramedics.

The videos on the thumb drive were transferred to a DVD.
