I received a thumb drive with video surveillance taken from McDonalds at the time of this incident. Management at McDonalds gave me the video.

The video surveillance contained five cameras from inside McDonalds. Different cameras captured S-Russell entering the business and assaulting V- [REDACTED] as well as S-Russell going behind the counter and attempting to assault employees. The cameras capture V- [REDACTED] subduing S-Russell and detaining him until police arrive. The cameras capture Officer Cuevas handcuffing S-Russell and waiting for assisting officers arrive. The cameras then capture Officer Cuevas and Sergeant Medici carrying S-Russell outside to be treated by paramedics.

The videos on the thumb drive were transferred to a DVD.

- 12:40:13 Suspect appears in dining area and approaches ██████████ who is dining at a table near the soda machine. Suspect immediately takes a fighting stance and starts to kick ██████████ Security Guard intervenes and the suspect moves towards counter, still trying to fight customers and the security guard. **(Cameras 08 and 13)**
- 12:40:45 Suspect goes behind the counter and tries to fight with employees. ██████████ follows behind the counter. **(Camera 02)**
- 12:41:04 Suspect is still swinging at employees. ██████████ approaches from behind and places the suspect in a Carotid restraint. **(Camera 20)**
- 12:41:28 Suspect's feet are moving while ██████████ is still holding him. ██████████ holds the suspect until police arrive. Does not appear to be using Carotid restraint. **(Camera 20)**
- 12:50:30 Office Cuevas arrives. Places handcuffs on suspect. Moves suspect onto his left side. **(Camera 20)**
- 12:52:10 Sergeant Medici arrives. **(Camera 20)**
- 12:52:49 Officer Gutierrez arrives. **(Camera 20)**
- 12:57:30 Paramedics arrive. **(Camera 20)**
- 12:58:30 Sergeant Medici and Officer Cuevas carry suspect outside the restaurant. **(Camera 02)**

Camera 03 – Behind counter and order line.

Camera 08 – Main dining area.
