62. Narrative of Supplemental Report

On Tuesday, 24 July 2018 at approximately 1210 hours, Sergeant M. Crawford #1213 verbally requested that I attend an autopsy for an Officer Involved Fatal Incident (OIFI) scheduled for the following day. On Wednesday, 25 July 2018 at approximately 0900 hours, I met with Detective D. Smith #444 and attended the autopsy of RUSSELL, David (DOB: 04/24/1985) at the Riverside County Sheriff (RSO) Perris Coroner's Facility.

I took 114 digital photographs. Evidence was collected by RSO Forensic Specialist II C. Kopitzke #N3863 at the request of Detective Smith (RUS001 - RUS007; see Evidence Log and Property Report for details). I received all evidence items from Forensic Specialist II Kopitzke at approximately 1045 hours.

After returning to the Magnolia Station of the Riverside Police Department, I laid out RUSSELL's property from the hospital bag (RUS002 - RUS003) and took 40 photographs. I later uploaded all photographs to the Digital Information Management System (DIMS).

After photographing, I placed all clothing items in the secured biohazard lockers to dry. Once dry, I packaged each item (with drop cloth) in paper bags, and placed all the paper bags back into the original packaging. I used all evidence items to Magnolia Station Property Locker #32 at approximately 1003 hours on Thursday, 26 July 2018.
