BODY WORN CAMERA

I was wearing my issued body worn camera during this incident and it was turned on and working. While positioning Police Service Dog Hyde onto my shoulder to enter the residence, the camera did get turned off and was turned back on during the safety sweep as soon as I noticed it was off.

DETAILS:

On Thursday, 03/08/18 at 1741 hours, I responded to 9931 Willowbrook Road in the city of Jurupa Valley within Riverside County reference a 11-11 (Emergency) backup for units with the Riverside Police Department (RPD).

I arrived and seen several RPD officers inside the garage of the residence in black raid vest with clearly visible "Police" on the front and back of the raid vest. One officer was waving for me to come to him. I exited my patrol vehicle and grabbed Police Service Dog (PSD) Hyde and ran into the garage. The unidentified officer told me that the residence had not been cleared yet and needed my assistance in doing so.

I looked inside and could see several officers inside taking cover positions and one officer attending to the suspect laying on the ground. I put PSD Hyde on my shoulder and walked to the end of the small walkway inside of the residence passing the suspect. After making several K9 announcements, I assisted the officers in conducting a safety sweep of the residence and backyard.

I responded back to my patrol vehicle which was parked in the driveway and moved it out of the way so medical personnel could have easier access to the garage and entryway where the suspect was. I took a perimeter position at Foxborough Ct. and Willowbrook Rd. I was relieved at 2120 hours and took no further action in this matter.
