### DETAILS:

3 On Thursday, March 8, 2018, at 6:12pm, Riverside County Sheriff's Department Sergeant Benjamin Ramirez  
4 called me requesting my assistance with an Officer Involved Shooting incident at 9931 Willowbrook Road,  
5 Jurupa Valley, CA 92509. Sgt. Ramirez explained the incident involved officers from the Riverside Police  
6 Department and requested I respond to the command post, at Woodbridge Ln. and Foxborough Rd., for the  
7 incident briefing.  
8

9 Upon my arrival, at 7:25pm, I arrived at the designated command post location and met with the other Central  
10 Homicide Unit (CHU) Investigators Anthony Johnson, Nelson Gomez, and Joshua Manjarrez. Also attending  
11 the incident briefing were Jurupa Valley Sheriff's Station (JVS) Sergeant Todd Torrenti, Riverside County  
12 Deputy Coroner Lily Gonzalez, Forensic Services Technicians Maria Whaley, Ashley Scott and Jane  
13 Muschell. Also attending the incident briefing was Riverside County Deputy District Attorney Chris Cook.  
14

15 The incident brief was presented by JVS Sergeant Raymond Ricken. He explained six officers from the  
16 Riverside Police Department (Evan Wright, Abel Soria, Jeffrey Pap, Robert Monreal, Sancho Lopez, and  
17 Henry Park) were surveying 9931 Willowbrook Road based on information that suggested an attempted  
18 murder suspect (Ernie Saldivar) was at that location.  
19

20 After Ernie was seen inside the garage, the RPD officers approached the residence. Upon entry into the garage,  
21 they contacted two adults [REDACTED] while Ernie hurried into the residence through the  
22 interior garage door. Ernie ignored the officers' commands and his actions caused the officers concern for  
23 their welfare. Shots were fired and Ernie was struck several times. He lay in the hallway of the residence and  
24 was deemed deceased at 5:57pm.  
25

26 After the shooting, the residence was checked and a woman [REDACTED] were  
27 contacted and escorted out of the residence. Once the residence was secured, notification to the Riverside  
28 County Sheriff's Department was made and patrol deputies responded to the location.  
29

30 The involved RPD officers, [REDACTED] were transported to the Jurupa Valley  
31 Station and awaited interviews.  
32

33 After the briefing, Inv. Johnson was assigned lead investigator on this matter. Inv. Gomez assisted him as his  
34 second investigator. Inv. Manjarrez remained at the residence and processed it for evidence. I was assigned  
35 to process and chart the RPD officers and interview [REDACTED].  
36

37 I then returned to the Jurupa Valley Sheriff's Station to process the RPD officers. This is an open investigation  
38 and its status reflects it. A copy of this report was sent to Inv. Johnson and incorporated into the investigation  
39 file.
