Details:

The following is a supplemental report reference the Officer Involved Shooting that occurred on 03/08/18 at 9931 Willowbrook St., in the city of Jurupa Valley involving members of the Riverside Police Department METRO team. The suspect in this incident was Ernie Saldivar.

On 03/12/18, I was contacted by Det. Brian Adcox of the Riverside Police Department Gang Unit. Det. Adcox told me that he was investigating a 245 PC that occurred on 8/19/17 in the city of Riverside on the 2200 block of Georgia St. (incident report # P17-150151). On that day the victim was seated in his parked vehicle when the suspect vehicle, a grey sedan, occupied by four HMA's, parked next to him. At that time one of the occupants in the suspect vehicle fired 4-5 gunshots at the victim, striking him in the left thigh and buttocks. During the investigation, Det. Adcox developed information which lead him to believe Ernie Saldivar was responsible for the shooting. On 8/26/17, RPD officers responded to 4251 Langston Pl reference a shooting. On arrival, a female stated that her ex-boyfriend and child's father shot at her after arguing with her about dating someone else. The suspect was identified as Ernie Saldivar. Saldivar shot at the female's vehicle and fled the area in a silver Toyota Camry. The vehicle matched the description given during the 245 PC. Based on statements and evidence obtained at both incidents, Det. Adcox believes the pistol Saldivar was armed with at the time of his death was possibly the weapon used in both assaults. Det. Adcox requested that I release the semi-automatic Hi-Point .380 caliber pistol that was taken as evidence during the Officer Involved Shooting investigation to him for ballistic testing reference his investigation.

On 3/28/18, at 1300 hours, I met Det. Adcox at the Jurupa Valley station evidence room. I retrieved the pistol (BN# 2041902) and released it to Det. Adcox for ballistic testing at DOJ. Once testing is completed, the pistol will be returned to the custody of the Riverside County Sheriff's Department.
