DETAILS:

On Thursday, March 8, 2018, I assisted Riverside County Sheriff Department Central Homicide Unit Investigator Anthony Johnson with an Officer Involved Shooting (OIS) incident at 9931 Willowbrook Road, Jurupa Valley, CA 92509.

This report was authored to incorporate the Riverside County Sheriff Department's Forensic Services Identification Report related to the charting of the Riverside Police Department officers involved in the OIS. Forensic Technician (FT) Jane Muschell completed a comprehensive report documenting her investigative actions during the charting process on March 8, 2018.

FT Muschell took one hundred forty-two (142) photographs of the officers, their attire, their weapons, and how they were loaded. The photographs taken were wide angle and close-up images of the officer and their equipment. The report also outlined three items of evidence were collected and provided to me for further processing.¹

This is an open investigation and this report's status reflects such. A copy of this report was incorporated into the investigation file managed by Investigator Johnson.
