Narrative of Supplemental Report:

On 12/29/16 at approximately 1950 hours, I was notified by Sergeant A. Levesque to respond to Riverside Community Hospital (RCH) to assist with an in-custody death investigation. I arrived at the location at approximately 2100 hours and met with Detective R. Wheeler for briefing. I began taking my photographs of Dominic William Smith DOB 04/03/79 at approximately 2021 hours. I then received evidence items SL01 - SL05 from Riverside Deputy Coroner Gonzalez N4294 at approximately 2212 hours (see attached Property Report for full item descriptions). I finished my assignment and left the location at approximately 2226 hours. I then responded to scene (Washington Park) and met with Detective M. O'Boyle for briefing. I began taking my photographs at approximately 2306 hours. I then collected evidence items SL06 and SL07. I finished my assignment and left the location at approximately 2325 hours. I returned to the Magnolia Station and placed all evidence items into the evidence vault at approximately 2337 hours. I then photographed the (2) Sergeants and (4) Officers who were on scene for the incident. At approximately 0030 hours, at the request of Det. O'Boyle, I responded back out to Washington Park to photograph and collect additional evidence. I arrived at the location and met with Officer B. Brandt, who guided me to the additional evidence. I took my photographs and collected a pair of copper pipe nun chucks and labeled them evidence item SL08. I finished my assignment and left the location. I returned to the Magnolia Station and placed evidence item SL08 into the evidence vault at approximately 0110 hours. I then downloaded (116) digital photographs into a secure file format.

On 1/04/17 at approximately 1455 hours, I retrieved all evidence items from the evidence vault for processing. I released all evidence items to Police Property Specialist S. Robinson at approximately 1523 hours.

No further action was taken.
