62. Narrative of Supplemental Report On 10-31-08, approx. 2150hrs., partner Officer Pilot R. Estes #1209 and I were on routine aviation patrol in N5074L, when we heard a call of a subject (5150 WIC) in the middle of the roadway at Cypress Av./Van Buren Blvd. Upon arrival, I saw the subject, wearing what appeared to be dark clothing standing in the middle of Cypress Av. between Montgomery St. and Warren St. Traffic was backing up at least 4-5 cars deep in both directions (East and West) and the subject was forcing cars to turn towards the road side to avoid hitting him. The subject was waving his arms and walking towards the cars as they past him. I told radio I saw the subject and his location. I saw a marked Police unit arrive onscene and two uniformed Police Officers get out of [Redacted] vehicle. The Officers approached the subject in the roadway, when I saw the subject move towards the Officers and I could see the subject fighting with the them. I told dispatch the subject was struggling with the Officers and requested additional units to the scene.
