Narrative of Supplemental Report:

On 11/4/08, Sergeant M. Rossi requested that I photograph a tarp located in Riverside Police Department Unit #3746. At 1312 hours, I arrived at Unit #3746, located in the Magnolia Station parking lot. I took (19) digital photographs of Unit #3746 and the tarp located on the front passenger seat. I labeled the tarp Evidence Item #V1: (1) "RIPP Restraints, Inc" black tarp, with #1 on yellow metal hook. I released the tarp back to the vehicle after I photographed it. At 1327 hours, I cleared Unit #3746. I downloaded the photographs to a secure file format. No further action was taken.
