Visible injuries or markings

Left rib cage area - Possible physical impact marking.

Right knee area – Possible baton strike.

Right rear thigh - Bruising and possible baton strike.

Left outer thigh - Parallel line strike from possible baton.

Left rear thigh above knee - Possible baton strike with abrasion towards inner thigh.

Left rear knee - Possible baton strike.

S. Acourade had an abrasian to the inside of his lower lin

Taser markings

S-Acevedo had two taser markings to his stomach area. One of the taser barbs was still attached to Acevedo at the time of the autopsy. The markings were approximately three inches apart.

S-Acevedo had two taser markings to his right rib cage area. No taser barbs were present. These markings were possibly from the "contact" tase administered by officers during the altercation. These markings were approximately two inches apart.
