62. Narrative of Supplemental Report On 021812, at approximately 1445 Hours, I heard a radio broadcast by Sgt. W. McCoy saying there had been shots fired at their location. He said the suspect was down and the officers were Code-4 (not hurt). He requested medical aid for the suspect. I confirmed over the radio the status of the officers and directed someone at the scene to take control and begin directing cars to where they would be needed. I also confirmed that Code-3 responses were not necessary and instructed that they should not be used. Sgt. McCoy agreed with that and said so over the radio. I drove to the scene and spoke to Sgt.'s R. Whitt and W. McCoy. It was then I learned they were the shooting officers. I instructed them to not discuss the incident with each other and I asked standard questions regarding public safety (direction of fire, outstanding suspects...etc.). Once those matters were addressed I asked Sgt. C. Mason to take Whitt and McCoy to the Magnolia Station to wait for investigators. I remained on scene and made departmental notifications.
