1 **Narrative:**

2 On 02-18-12, at about 1447 hours, Officer Wilcox and I responded to a shots fired call that was
3 broadcast in the area of Harold and Philbin. Upon arrival, I parked the unit at the corner of Philbin and
4 Harold and began pulling crime scene tape, blocking off public access to Harold.

5
6 I began canvassing the immediate area where the Officer involved shooting occurred and spoke to
7 several residents who provided the following statements which were recorded and downloaded into
8 Coban.

10 **O1-Wilson's Statement:**

11 I spoke with O1-Wilson and he said he was in his backyard when he heard four shots, that he thought
12 were firecrackers.

14 I spoke the residents of 5638 Harold who provided the following statement.

16 **O2-Durprip's Statement:**

17 O2-Durprip said she was inside of her residence cleaning and did not hear any gunfire or see anything.

19 **O3- [REDACTED] Statement:**

20 O3- [REDACTED] said he was inside the residence when he heard five shots, but stated he did not see anything.

22 **O4-Harbans' Statement:**

23 O4-Harbans did not speak English, but stated she heard five shots. O4-Harbans statement was translated
24 by O3- [REDACTED]

26 I spoke to the residence of 5653 Harold who provided the following statement.

28 **O5-Lori's Statement:**

29 O5-Lori said she was inside her residence when she heard about five shots. O5-Lori ran to the front door
30 and saw three "SWAT" members standing near S-Bond; pointing their guns at him while S-Bond lay on
31 the sidewalk.

33 **O6-Zuniga's Statement:**

34 O6-Zuniga said she was also in the residence when she heard "Drop It!" O6-Zuniga then heard five
35 gunshots. She immediately ran to the bedroom window that faces Harold and saw S-Bond on his back.

37 After collecting neighbor statements, I stood at the corner of Harold and Philbin, preventing anybody
38 from entering the crime scene.
