1 Scene Description/ Background:

2 I responded to an OIS in the area of Harold St. and Philbin Ave. Once on scene I assisted with securing a
3 perimeter. I then took multiple statements during an area canvas.
4

5 Narrative:

6 On 2-18-12, at approximately 1455 hours, Officer Kerr and I responded to the area of Harold St. and
7 Philbin Ave., located in the City of Riverside reference an officer involved shooting. I assisted in
8 securing the perimeter and taking multiple statements during an area canvas.
9

10 Statements:

11 I spoke to W-1 Maria Ceja (5665 Harold St.) at the scene and she told me the following statement:
12 Ceja was home and inside her residence at the time of the shooting. Ceja heard an unknown amount of
13 gunshots coming from the front of her residence at approximately 1455-1505 hours. Ceja didn't see or
14 hear anything else.
15

16 I spoke to W-2 Eliana Gallegos (5673 Harold St.) at the scene and she told me the following statement:
17 Gallegos was home and inside her residence at the time of the shooting. Gallegos heard approximately 4
18 gunshots coming from the front of her residence at approximately 1455-1505 hours. Gallegos didn't see
19 or hear anything else.
20

21 I spoke to W-3 Nancy Marquez (5623 Harold St.) at the scene and she told me the following statement:
22 Marquez was home and inside her residence at the time of the shooting. Marquez heard approximately
23 4-5 rapid gunshots coming from the front of her residence at approximately 1455-1505 hours. Marquez
24 also heard unknown vehicles roaring/ driving fast down her street in an unknown direction. Marquez
25 didn't see or hear anything else.
26

27 I spoke to W-4 Damien Moreno (5623 Harold St.) at the scene and he told me the following statement:
28 Moreno was home and inside his residence at the time of the shooting. Moreno heard approximately 4-5
29 gunshots coming from the front of his residence at approximately 1455-1505 hours. Moreno didn't see or
30 hear anything else.
31

32 I attempted to contact the residence at 5611 Harold St. but it was vacant.
33

34 I spoke to W-5 Glenda Wilson (5599 Harold St.) at the scene and she told me the following statement:
35 Wilson was home and inside her residence at the time of the shooting. Wilson heard approximately 5
36 gunshots coming from the front of her residence at approximately 1455-1505 hours. Wilson didn't see or
37 hear anything else.
38

39 I spoke to W-6 Abigail Cendejas (7571 Gramercy Pl.) at the scene and she told me the following
40 statement:
41 Cendejas was home and inside her residence at the time of the shooting. Cendejas heard approximately 5
42 gunshots coming from the front of her residence at approximately 1455-1505 hours. Gallegos didn't see
43 or hear anything else.
