STOLEN VEHICLE:

V-1/Antonia's burgundy 1994 Honda Accord 4DR (4EFE501)

NARRATIVE:

On 02-25-13, at approximately 1952 hours, I was dispatched to 5060 Arlington Ave (Chase bank) reference a past GTA call. I arrived on scene and contacted the registered owner of the vehicle, V-1/Antonia.

STATEMENTS:

V-1 stated the following: On 02-25-13 at 1900 hours she arrived at the above listed location. V-1 parked the above listed vehicle in the parking lot to the front of Chase bank. V-1 told me that when she left the vehicle the doors were closed and locked and the windows were rolled up. V-1 went inside the Ross clothing store in the complex and shopped for approximately 45 minutes. When she returned at 1950 hours, she discovered an unknown suspect had stolen her vehicle. V-1 stated no one had permission to take the vehicle and she desires prosecution.

INVESTIGATIVE ACTIONS:

I conducted an area check for the vehicle in the parking lot and did not locate it. I sent out an APR to other units via MDC and dispatch entered the vehicle into SVS.
