Shortly after my arrival, I contacted Officer Lopez and Officer Brett Porter to the front of the residence. I asked Officer Lopez how many rounds he fired and in what direction. Officer Lopez told me he had already advised Sergeant Lambert of that information. I told him that was fine, just so long as he had advised supervision. Officer Lopez then indicated he fired in an easterly direction from the backyard. Officer Lopez then removed his magazine from his weapon, which he left in his holster, and advised he had 10 rounds in his magazine. Officer Lopez then replaced his magazine back into his weapon.		
A proximately 0300 hours, I responded to Riverside Community Hospital, where the suspect had been transported to. Officer Feimer was at the hospital with the suspect. I arrived there at 0310 hours. The
