62. Narrative of Supplemental Report <b>On Thursday, 03-01-12, at approximately 0229 hours, I responded to the area of Anna and Lincoln reference an Officer Involved Shooting. I arrived on Anna and noted a white Ford Windstar (CA lic [REDACTED] parked near the middle of the street with RPD unit 3908 behind it. Both vehicles were parked near the front of 2966 Anna and were facing N/B. I exited my patrol car and noted both front doors on the Windstar left open. I conducted a safety sweep of the Windstar and found no person(s) inside of it. I then inspected the patrol unit behind the Windstar and discovered O/ Smith in the back seat without handcuffs. Officers Simpson and Samano arrived at my location shortly thereafter. It was at this time that Officer [REDACTED] took O/ Smith out of the patrol unit and conducted a pat down search of his person. O/ Smith was then handcuffed and placed back inside of the patrol unit. I received a telephone call from Sgt. D. Ruddy at approximately 0320 hours instructing me to take O/ Smith out of the patrol unit and out of the crime scene.
