At 0234 hours, we arrived and assisted in setting up the crime scene at Hyde Park Circle. I set a perimeter using crime scene tape, and afterward was instructed to take a statement from O1/ Mary LaSalle who resides at [Redacted]

O1LaSalle Recorded Statement:
LaSalle said the sound of three gun shots, followed by two more gun shots woke her up at approximately 0230 hours. She got out of bed and opened her front door and looked outside. She could not see anything, but could hear the voice of her neighbor Craig Dales who resides at [Redacted] yelling "No, you cannot come in!" LaSalle said she heard knocking on a door near Craig Dales residence. LaSalle went inside to call 911.
