Narrative:

I contacted the resident at [REDACTED]. The resident, [REDACTED] told me he was sleeping during the incident and did not see or hear anything.

I contacted the resident at [REDACTED], O-1/Camilon, who stated the following (recorded); She was sleeping when she heard "two loud bursts" at approximately 0230 hours. She then heard numerous police sirens shortly after.

I contacted the resident at [REDACTED], O-2/Scott, who stated the following (recorded); She was sleeping during the entire incident. She did not see or hear anything and only woke up after I knocked on the door to contact her.
