Narrative of Supplemental Report:

On 3/1/2012, I received a phone request from Sergeant L. Williams to assist processing the scene of an Officer Involved Shooting. At 0420 hours, I arrived at the Magnolia Station. At the direction of Supervising Forensic Technician C. Fuller, I reported to Riverside Community Hospital (RCH), 4445 Magnolia Avenue, at 0504 hours. I reported to Emergency Room #M, and contacted Officer K. Feimer and Detective J. Simons. I took (43) digital photographs of Suspect: Brandon J. Dunbar [REDACTED], assisted by Deputy Coroner R. Escobar. I took possession of Evidence Items #BD01 and BD02 from Dep. Cor. Escobar. Refer to the attached Evidence Log and Photo Logs. At 0705 hours, I cleared RCH with Items #BD01 and BD02. At the direction of Supv. Fuller, I reported to the intersection of Anna Street and Lincoln Avenue to assist processing the scene. I contacted Supv. Fuller, who gave me an incident brief. Supv. Fuller assigned me to conduct multiple metal detector searches. I conducted metal detector searches on the following areas:

- 2914 Hyde Park Circle (west grassy/ foliage area): No projectile located
- Anna Street grassy/ foliage area, west of 2914 Hyde Park Circle: (1) Casing located, Evidence Item #CF11
- 2914 Hyde Park Circle (east grassy/ foliage area): (1) Projectile located, Evidence Item #CF20.

Supv. Fuller assigned me to visually search for projectiles behind the south backyard bushes of 2914 Hyde Park Circle. I located (2) projectiles, Evidence Items #CF18 and CF19. Refer to the supplemental report of Supv. Fuller.
