On 12/31/13 at 1133 hours, I was dispatched to 3860 Van Buren Blvd. to assist officers reference an "11-11" call. I arrived on scene first and made contact with Officer Asbury and Officer Miranda in the playground area of the park. I asked Officer Asbury and Officer Miranda if they were alright. They both said "yes." I discovered a black male adult laying on his back with an obvious gun shot wound to the left side of his head. I asked Officer Asbury if there was anyone else that we needed to be looking for. Officer Asbury told me that everyone was accounted for. Next to the black male adult was a silver semi automatic handgun. I noticed that the hammer was back in a locked position ready to fire. Officer Espinoza arrived on scene to assist and we both put on latex gloves. I assisted Officer Espinoza in searching the suspect. Once he was searched I assisted Officer Espinoza with handcuffing the suspect. RFD arrived on scene and pronounced the suspect deceased.											VCL0 ( )
