During the investigation into the Officer Involved Shooting on 12/31/13, Witness [REDACTED] was brought to the Magnolia Station. She was present during the shooting of S-Hayes.

Prior to interviewing W-[REDACTED] I learned that she was reported as a Runaway Juvenile. Due to her age, we could not release her until her parents or guardian was located.

W-[REDACTED] was upset and hysterical while she was at the station. I asked her if I could speak to her about what happened at the park. She kept asking me if her boyfriend (S-Hayes) was dead. I finally told her he was dead. She became more hysterical.

I asked W-[REDACTED] if she would tell me what happened at the park. Between her yelling and crying, she said S-Hayes pulled out a gun. She said she tried to stop him. She would not elaborate or give any further specific details about S-Hayes pulling out a gun or her trying to stop him.

W-[REDACTED] then said that she knew S-Hayes had the gun and that they were going to sell it. She said they were going to sell it and be rich. She would not elaborate or give any further specific details about S-Hayes and the gun.

W-[REDACTED] was so hysterical that I could not interview her any further.

W-[REDACTED] mother, [REDACTED] was located and W-[REDACTED] was released to her.
