

On 1/3/14, I received an e-mail which was sent to RPD Chiefonline from O-1 Elliott. O-1 stated in her e-mail that on 12/29/13 she met a male black on the street who told her he "felt like doing something to get locked back up". When she asked what he was going to do he said, "Just get them to do me like Tyeshia Miller".

O-1 Elliott said that she read about the Officer Involved Shooting at Arlington Park and thought the male she talked to may be related to this case. She said she could identify the male again if she saw a photo of him.

While on the phone with O-1 Elliott, I e-mailed her a photograph of S-Hayes. When she received the photo, she immediately told me that S-Hayes was the person she spoke to on 12/29/13.

O-1 Elliott had no further information.
