On 12/31/13 at approximately 1150 hours, I was notified by Sergeant D. Amador to respond to 3860 Van Buren Blvd. (Arlington Park) for an Officer involved shooting investigation. I arrived at the location at approximately 1220 hours and met with Sgt. Amador and Detectives for briefing. I began videotaping the scene at approximately 1318 hours (later labeled evidence item BL32). I then began taking my overall, medium and close-up photographs of the scene. With the assistance of Sr. Forensic Technician S. McKay-Davis, I measured all evidence items (see attached diagram). Next, I collected evidence items BL01 - BL31 (see attached Evidence Log and/ or Property Report for full item descriptions). I finished my assignment and left the location at approximately 1930 hours. I returned to the Magnolia Station and placed all evidence items in the evidence vault at approximately 1935 hours. I then downloaded (179) digital photographs into a secure file format (see attached Photo Log).

On 01/02/14 at approximately 0950 hours, Det. Cobb and I responded back to the scene to take additional photographs and measurements of possible strike marks. We left the location at approximately 1025 hours. I returned to the Magnolia Station and downloaded (22) digital photographs into a secure file format.

On 01/06/14 at approximately 1230 hours, I retrieved all evidence items (with the exception of evidence item BL32) from the evidence vault for processing. I took additional photographs of evidence item BL10: COLT 45 semi-auto handgun. I then downloaded (4) digital photographs into a secure file format. I finished my assignment and released all evidence items (with the exception of evidence item BL32) to Police Property Specialist K. Brown at approximately 1510 hours.

On 01/07/14 at approximately 1430 hours, I received a request from Det. Rick Cobb to transport evidence items BL09A, BL10, BL10B, BL28, NA01, NA01-A, PM01 and PM01-A to the Department of Justice (DOJ) Riverside Criminalistics Laboratory for analysis.

On 01/08/14 at approximately 0826 hours, I received all evidence items from Police Property Specialist S. Robinson and placed them into my secured evidence locker. At approximately 0950 hours, I retrieved all evidence items from my secured evidence locker and transported them to DOJ. I arrived at the location and released all evidence items to Property Controller 1 C. Freer at approximately 1036 hours (see attached BFS Submission Form RI-14-0072). I finished my assignment and left the location. I then received a request from Det. Cobb to have evidence item BL22: Gun Shot Residue (GSR) kit for S/ HAYES, Dontae Daveon DOB 04/27/93 sent to the LA County Coroner's Office for analysis and evidence item AUT09: (1) vial of blood from S/ HAYES transported to DOJ for analysis.

On 01/09/14 at approximately 0855 hours, I received evidence item BL22 from Police Property Specialist S. Robinson and mailed it to the LA County Coroner's Office via UPS. I also received evidence item AUT09 and transported it to DOJ. I released it to Property Controller 1 C. Freer at approximately 0950 hours. At approximately 1340 hours, I retrieved the scene video from the evidence vault and made a (1) Master Copy and (1) Working Copy DVD of the scene. I labeled those DVD's evidence items BL32 and BL32A. I then placed both evidence items into my secured evidence locker.

On 01/16/14 at approximately 0940 hours, I returned to DOJ to pick up evidence items BL09A, BL10, BL10B, BL28, NA01, NA01-A, PM01, PM01-A and (3) new items TF-PM01, TF-NA01 and TF-BL10 (see attached BFS Submission Forms RI-14-0072 and RI-14-72-1). I left the location and returned to the Magnolia Station and released all evidence items to Police Property Specialist K. Brown at approximately 1038 hours.

On 03/11/14 at approximately 1100 hours, I retrieved evidence items BL32 and BL32A from my secured evidence locker and put them into the Magnolia Station Evidence Locker #43.

No further action was taken.





