Investigation:

On July 11, 2013 I spoke with W/Carol Lopez by phone about this incident. The interview was audio recorded and what follows is a synopsis of that interview.

W/Carol Lopez:

On the night of June 11, 2013 Carol and he husband were driving west on the 91 freeway with her husband driving and she as the front passenger. While traveling on the freeway, Carol saw an accident occur between two vehicles, one that was already on the freeway and another that had just merged onto the freeway. The merging vehicle was a larger black car and the other vehicle was a smaller red car. To Carol, it appeared that the red car ran into the black car soon after the black car had driven onto the freeway. Carol and her husband continued to the Van Buren Ave off ramp where they exited the freeway and prepared to make a right turn onto north bound Van Buren.

While stopped at a red light at the top of the off ramp, Carol saw a small red car drive past them and through the red light into the north bound traffic lanes of Van Buren. She watched as the red car drove into the center divider of the street and hit a sign. Carol could not be certain but she thought the car that crashed into the center divider on Van Buren, might have been the same one she saw crash into the black car on the freeway.

While still stopped at the red light, Carol watched as both the driver and front passenger exited the red car on the driver's side. They stumbled around for a moment or two and then began running north on Van Buren away from the car. During this time Carol saw that the passenger, a black male wearing possibly a red and gray shirt, carrying a handgun in his right hand. Seeing the handgun, Carol decided to call the police about what she was observing. Carol and her husband drove north on Van Buren from the scene, once the signal turned green.

Carol did not get a good look at either the driver or passenger of the red car before they left the scene so she did not feel that she could identify either one.
