I was called at my residence by Sgt. Amador at 2330 hours on 06-11-2013. I was asked to respond to the above documented location reference an Officer involved Shooting that had just occurred. Upon arrival to the crime scene I was present for the briefing given by Lt. Milby and Sgt. Tipe. I was assigned to interview the driver (C-1 Chapple) of the vehicle (2000 Chevrolet 4 door- burgundy—Ca-5XBU928) that S-1 Hopes was inside just prior to the shooting.

I spoke with C-1 Chapple at the RPD Magnolia Street Station on 06-12-2013 at 0240 hours. The interview was recorded and downloaded to the server. During the time of this interview C-1 Chapple was under arrest for 23152 CVC and 20002 CVC. C-1 Chapple was transported from the crime scene to the station by Officers Marroquin #16422 and Wenger #19165.

On 06-12-2013 at 0240 hours I met with C-1 Chapple at the Riverside Police Department Magnolia Street Station. I advised C-1 Chapple of his Miranda Rights (read from card) which he waived. C-1 Chapple admitted driving his vehicle and being involved in a traffic collision on the 91 Freeway (westbound). C-1 Chapple stated he exited the 91 Freeway at Van Buren Blvd. and thought the other involved vehicle followed him off the freeway. C-1 Chapple said as he exited the off ramp he lost control of his vehicle because it "wouldn't shift into gear". C-1 Chapple said his vehicle then came to a stop in the center median on Van Buren Blvd.

C-1 Chapple wasn't truthful throughout this interview. C-1 Chapple advised at first that he was alone while driving in his vehicle. C-1 Chapple continued to advise he was by himself until I told him S-1 was seen exiting his vehicle by witnesses. C-1 Chapple then changed his statement and admitted to being with S-1 Hopes. C-1 Chapple advised he was waved down on University Ave. by S-1 Hopes a short time before this incident. C-1 Chapple said S-1 Hopes asked him for a ride. I asked C-1 Chapple where S-1 Hope wanted a ride to and he answered "Riverside". I told C-1 Chapple where exactly in Riverside and he stated "Arlington". I asked how well he knew S-1 Hopes and he stated he had seen S-1 Hopes "in the streets" once before about 2 weeks ago. C-1 Chapple stated he didn't know his (S-1) name, nickname or moniker. I asked C-1 Chapple what he called him when they spoke and he replied "Bro".

C-1 Chapple told me he had picked up S-1 Hopes a few minutes after leaving his girlfriend's house in the Eastside of Riverside. When I asked her address he hesitated and said Moreno Valley. I then questioned him on why he wasn't being truthful after telling me she lived on the Eastside of Riverside. C-1 Chapple went on to say he met his girlfriend at a park on the Eastside. C-1 Chapple said the park was on 14<sup>th</sup> St. and had outdoor basketball courts (Bordwell Park). C-1 Chapple advised after leaving his girlfriend he drove over to University Ave. to go to a store and that's when he was waved down by S-1 Hopes. C-1 Chapple was unable to give an exact location on University Ave. where this took place.

C-1 Chapple told me it surprised him that S-1 Hopes ran from his vehicle when it came to a stop on Van Buren Blvd. C-1 Chapple didn't know why he did this. C-1 Chapple stated he had no idea if S-1 Hopes was in possession of a handgun advising he didn't see S-1 Hopes with one while inside his vehicle. C-1 Chapple said a short time after S-1 Hopes ran from his vehicle he heard gunshots. C-1 Chapple advised he heard the gunshots as he was being placed on the ground by police officers.

C-1 Chapple lied numerous times to me during this interview. C-1 Chapple showed no emotion at all for S-1 Hopes when told he had been shot and died. C-1 Chapple had soiled his pants during the initial incident and was more worried about that than S-1 Hopes.

I released C-1 Chapple to CHP Officers Marroquin and Wenger after the interview and he was booked into RPDC for 23152 CVC and 20002 CVC.
