Narrative of Supplemental Report:

On 1/20/2009, I received a verbal request from Supervising Forensic Technician C. Fuller to attend the autopsy of suspect: Russell Hyatt. On 1/21/09, at 0852 hours, I arrived at the Riverside County Sheriff-Coroner Morgue. I contacted Detective Rick Cobb and identified what items needed to be collected. The autopsy began at 0938 hours. It was attended by Det. Cobb, Sergeant M. Smail, Sergeant B. Daily, Riverside City Attorney J. Brown, Pathologist S. McCormick, Riverside Sheriff-Coroner Forensic Technician E. Devore, and Coroner Technician K. Rodriguez. I took (113) digital photographs of the autopsy and evidence items. For processing purposes, I separated the following evidence items:

Item #CM03: separated into CM03 and CM03-A

Item #CM04: separated into CM04 and CM04-A.

At 1150 hours, I took possession of Evidence Items #CM01-CM14 from Technician E. Devore. Refer to the Photo Logs and Property Report. The autopsy concluded at 1152 hours, and I cleared the morgue at 1209 hours. I transported the evidence items to the Magnolia Station and secured them in the evidence vault. I downloaded the photographs to a secure file format. At 1610 hours, I released Evidence Items #CM01-CM14 to Magnolia Station Police Property Specialist K. Duncan. No further action was taken.
